Temporary and Disability Assistance Statistics JULY 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 599,148 in July 2005, decreasing by 5,787 (-1.0%) from the previous month. Related expenditures totaled \$148,416,956 in July 2005 decreasing approximately \$8.3 million (-5.3%) over June 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,744,352 in July 2005, decreasing by 21,007 (-1.2%) over June 2005. Food Stamps expenditures totaled \$179,841,925 in July 2005, decreasing \$573,230 (-0.3%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For July 2005, SSI recipients (including Mental Hygiene) totaled 631,266 decreasing 4,106 (-0.6%) from the previous month. SSI expenditures in July totaled \$307,388,662 decreasing approximately \$5.3 million (-1.7%) from June 2005.

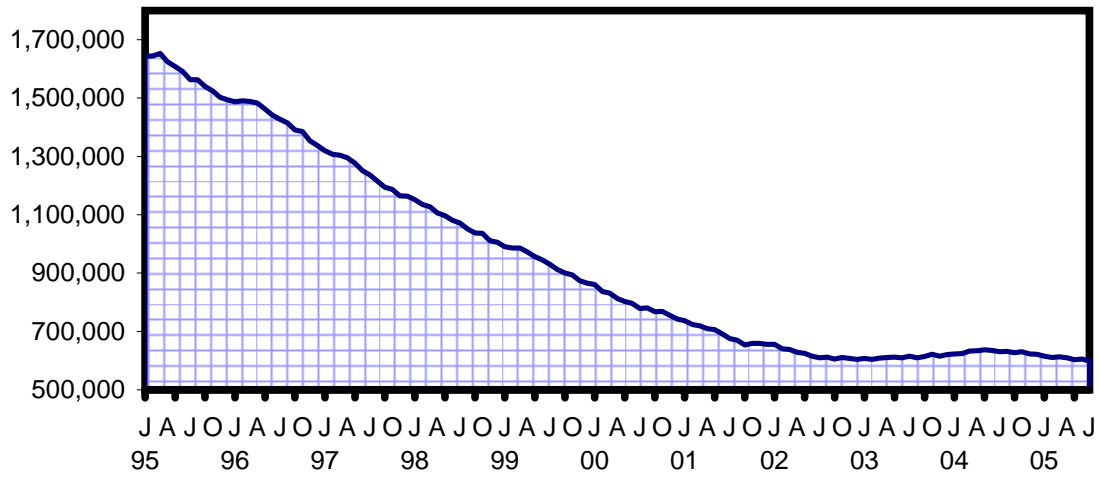

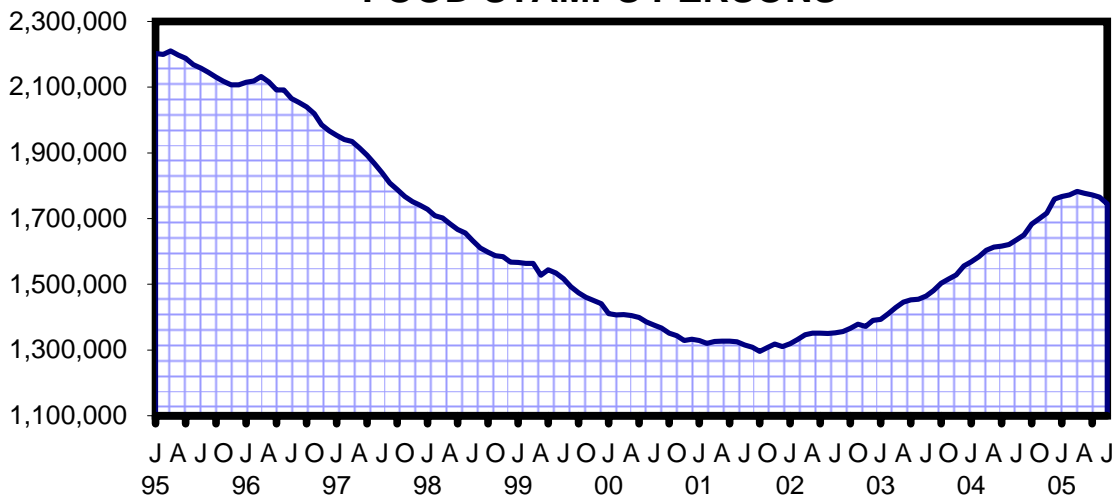

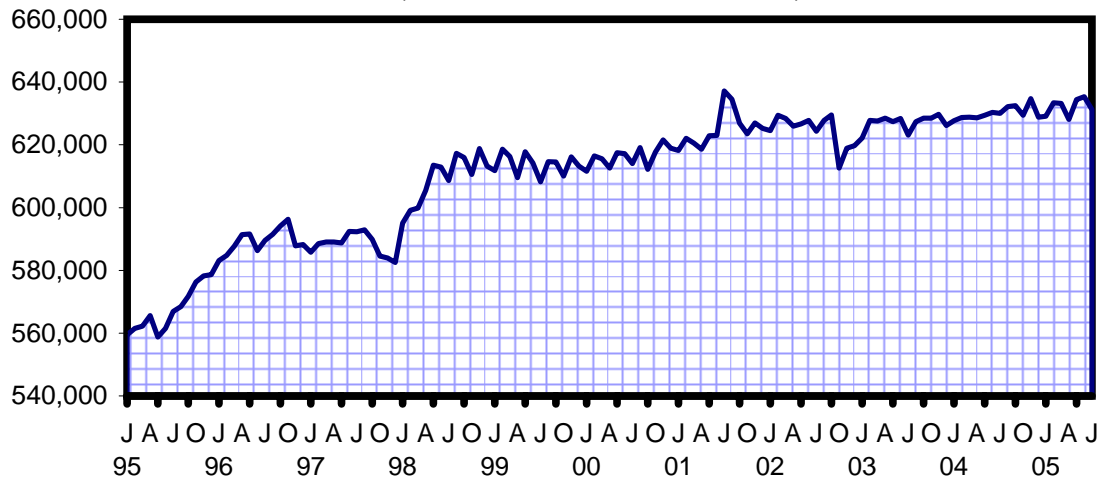
TEMPORARY ASSISTANCE RECIPIENTS
