MAY 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 602,993 in May 2005, decreasing by 6,588 (-1.1%) from the previous month. Related expenditures totaled \$153,322,304 in May 2005 decreasing approximately \$2.2 million (-1.4%) over April 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,772,242 in May 2005, decreasing by 4,520 (-0.3%) over April 2005. Food Stamps expenditures totaled \$179,846,767 in May 2005, decreasing \$425,339 (-0.2%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For May 2005, SSI recipients (including Mental Hygiene) totaled 634,415 increasing 6,345 (+1.0%) from the previous month. SSI expenditures in May totaled \$315,177,533 increasing approximately \$4.2 million (+1.3%) from April 2005.

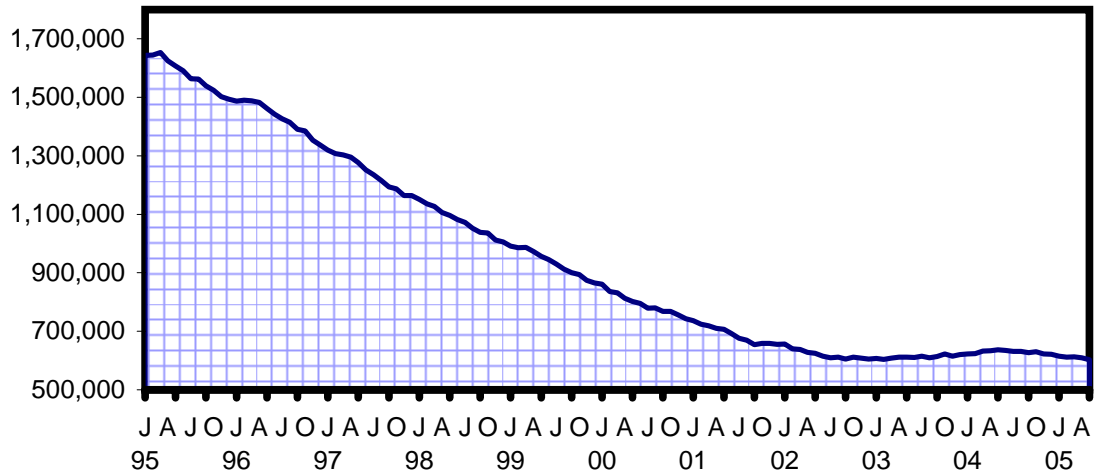

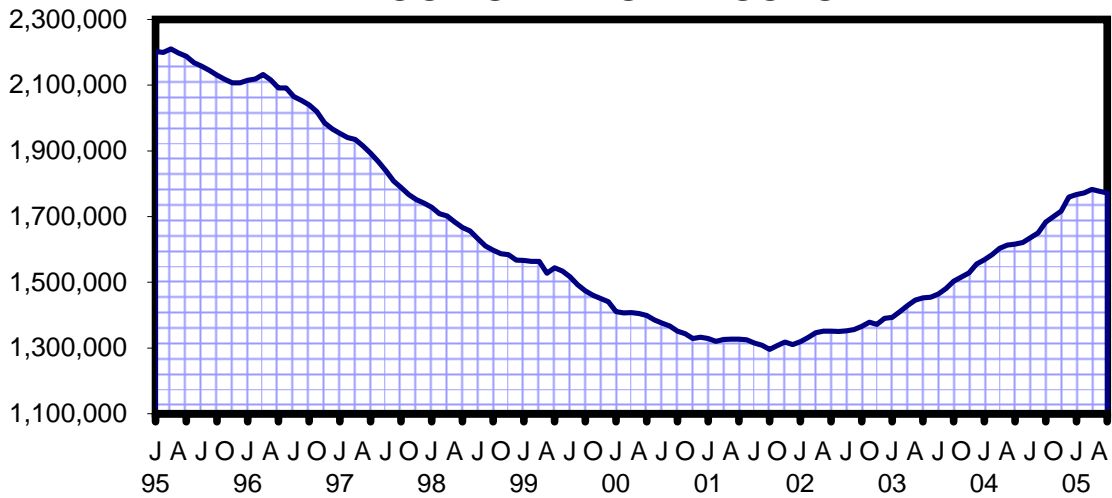

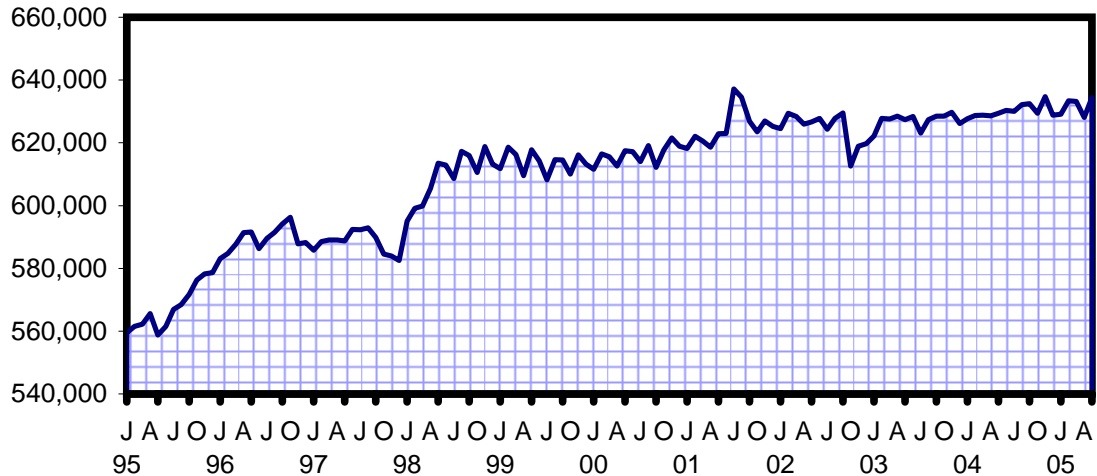
TEMPORARY ASSISTANCE RECIPIENTS
