Temporary and Disability Assistance Statistics

OCTOBER 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 602,758 in October 2005, increasing by 3,211 (+0.5%) from the previous month. Related expenditures totaled \$150,937,957 in October 2005 increasing by \$867,653 (+0.6%) over September 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,763,668 in October 2005, increasing by 6,129 (+0.3%) over September 2005. Food Stamps expenditures totaled \$187,072,589 in October 2005, increasing approximately \$5.2 million (+2.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For October 2005, SSI recipients (including Mental Hygiene) totaled 627,804 decreasing 5,116 (-0.8%) from the previous month. SSI expenditures in October totaled \$302,908,984 increasing approximately \$4.4 million (+1.5%) from September 2005.

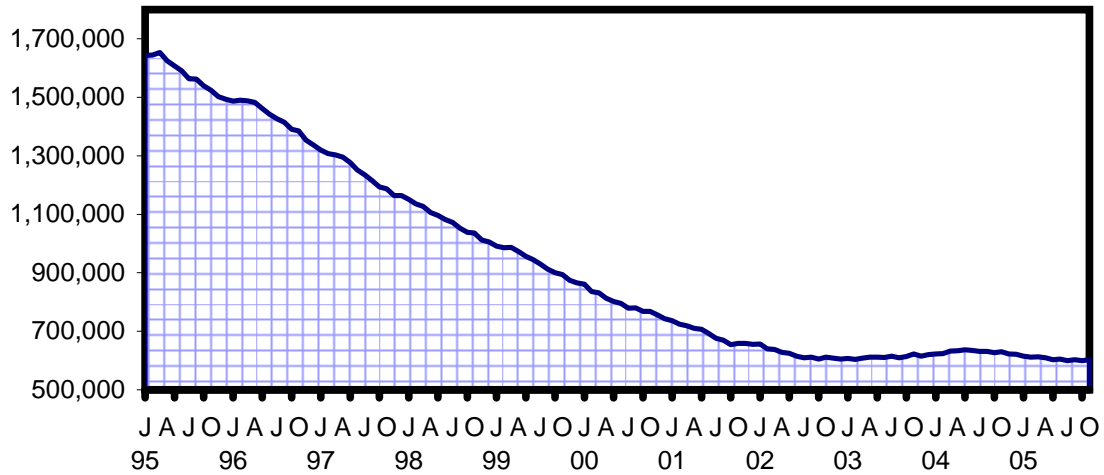

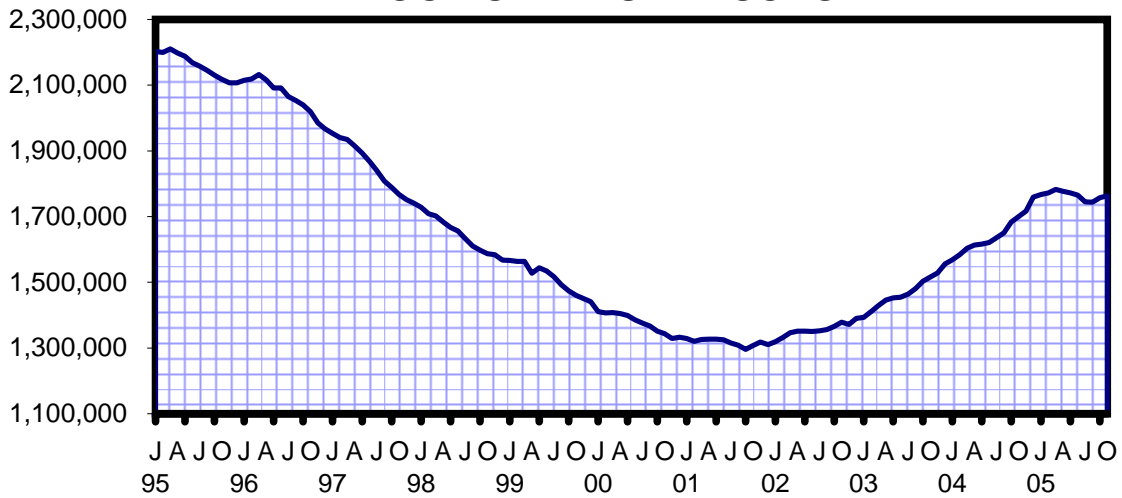

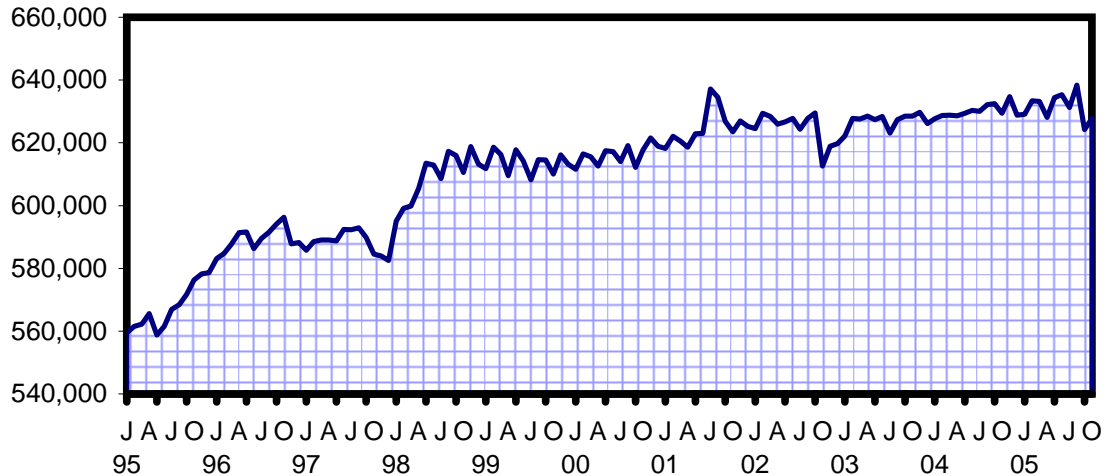
TEMPORARY ASSISTANCE RECIPIENTS
