[2020 年 7 月 1 日]

1. 生效日期

本規例自 2020 年 7 月 1 日起實施。

2. 釋義

在本規例中——

費用附表 (Fees Schedule) 指《助產士註冊 (費用) 規例》(第 162 章, 附屬法例 B) 的附表;

寬免期 (concession period) 指 2020 年 7 月 1 日至 2023 年 6 月 30 日 (該兩日亦包括在內) 期間。

3. 首次註冊費

(1) 費用附表第 1(a) 項受本條所規限。

(2) 如註冊助產士的首次註冊在寬免期內生效, 須就該項註冊繳付的費用是 \$0。

4. 執業證明書的費用

(1) 費用附表第 3 項受本條所規限。

(2) 在第 (3) 款的規限下, 如執業證明書在寬免期內生效, 須就發出該證明書繳付的費用是 \$0。

(3) 如向某人發出的超過一張執業證明書, 均在寬免期內生效, 則第 (2) 款只就該等證明書中最早生效者而適用。

Midwives (Fee Concessions) Regulation 2020

(Made by the Chief Executive in Council under section 23(1) of the Midwives Registration Ordinance (Cap. 162))

[1 July 2020]

1. Commencement

This Regulation comes into operation on 1 July 2020.

2. Interpretation

In this Regulation—

concession period (寬免期) means the period from 1 July 2020 to 30 June 2023 (both dates inclusive);

Fees Schedule (費用附表) means the Schedule to the Midwives Registration (Fees) Regulation (Cap. 162 sub. leg. B).

3. Fees for first registration

(1) Item 1(a) of the Fees Schedule is subject to this section.

(2) The fee payable for the first registration as a registered midwife that takes effect during the concession period is \$0.

4. Fees for practising certificates

(1) Item 3 of the Fees Schedule is subject to this section.

(2) Subject to subsection (3), the fee payable for the issue of a practising certificate that takes effect during the concession period is \$0.

(3) If more than one practising certificate issued to a person takes effect during the concession period, subsection (2) applies, as

far as those certificates are concerned, in relation only to the certificate that first takes effect.

5. Expiry

This Regulation expires at midnight on 30 June 2023.
