Research Output of Higher Education Institutions in Hong Kong, 1998/99 to 2008/09

1. 引言

- 1.1 研究及發展(研發)活動所產生的新知識的推廣與應用,是推動知識型經濟體系持續發展的重要元素。有關研究成果的統計數字, 是反映經濟體系在這方面成就的重要指標,並有助我們洞察科技上可發展的新範疇。
- 1.2 高等教育機構進行的研發活動,是推動 香港這方面活動的原動力。本文分析大學教育 資助委員會(教資會)所資助的高等教育機構 的研究成果統計數字。

2. 資料來源及定義

- 2.1 本文中有關研究成果的統計數字是根據 教資會的統計記錄編製而成,涵蓋教資會資助 的八間高等教育機構,即香港中文大學、香港 城市大學、香港浸會大學、香港教育學院、香 港理工大學、香港科技大學、嶺南大學和香港 大學。換言之,非教資會資助的學術機構的研 究成果,並不包括在本文所述的統計數字之 內。
- 2.2 **研究成果**涵蓋高等教育機構在指定統計期內(即當年七月一日至下一年六月三十日) 與教學無直接關係的創意作品。至於在統計期內獲期刊接納但並未出版的作品則不包括在內。

1. Introduction

- 1.1 The promotion and application of new knowledge generated through research and development (R&D) activities are crucial in sustaining the development of a knowledge-based economy. Statistics on research output are important indicators reflecting the achievements in this respect and offer insight into possible development of new fields of science and technology.
- 1.2 R&D undertaken by higher education institutions is the engine of such activities in Hong Kong. This article analyses statistics on research output of the higher education institutions funded by the University Grants Committee (UGC).

2. Data Source and Definitions

- 2.1 In this article, statistics on research output are based on the statistical records of the UGC and cover the eight UGC-funded higher education institutions namely, the Chinese University of Hong Kong, City University of Hong Kong, Hong Kong Baptist University, the Hong Kong Institute of Education, the Hong Kong Polytechnic University, the Hong Kong University of Science and Technology, Lingnan University and the University of Hong Kong. In other words, research output of academic institutions other than those funded by UGC is not covered in the statistics shown in this article.
- 2.2 **Research output** covers the creative work of higher education institutions which is not directly related to teaching during the specified reference period (i.e. 1 July of a year to 30 June of the following year). Items accepted by journals but not yet published within the reference period are not included.

- 2.3 根據教資會所制定的定義, **研究成果類** 別一般包括:(1)學術書籍、專題論文及章節;(2)雜誌期刊;(3)會議論文;(4)創意及文學作品、顧問報告及個案研究;(5)專利權、許可證協議、知識產權及註冊公司;以及(6)其他研究成果。
- 2.4 研究成果以著作、報告、設計、表演和展覽等項目的數目作計算。如屬於共同著作/ 羣體表演,計算方法是根據所涉及的作者/參 與者人數按比例分攤。例如一篇由四名作者共 同著作的文章每名作者各佔 0.25 篇。數字包括 教學及研究人員的研究成果。由二零零零/零 一年度開始,數字亦包括研究課程研究生的研 究成果。
- 2.5 經審閱的研究成果 指經一組專業人士 (「同科的學者」) 審核的學術研究成果,而 該組人士當中必須有相當人數來自機構以 外。同科的學者對學術研究的審核形式,會根 據學術範疇和作品類別而有所不同。但一般必 須由一組具備對高素質水平的研究有判斷能 力的人士擔任,他們工作時亦應與研究人員及 其部門保持一定距離。作品獲編輯或學術會議 主席接納並不構成「審閱」過程,但若將有關 作品發給同科的學者評估,這個程序卻能成為 「審閱」過程。研究書籍或專題著作、刊載於 經審閱的期刊內的文章,以及經審閱的會議文 件,均屬經審閱的作品。但機構內部的程序, 例如評審納入部門工作文件系列的稿件,並不 算是「審閱」。
- 2.6 **獎項**指由機構以外的其他機構所頒發具權威性的認可,不論是否涉及有形的獎勵。獎項包括在指定統計期內教學及研究人員,及研究課程研究生所獲頒與研究有關的獎項。

- 2.3 According to the definition set out by the UGC, *research output categories* generally includes: (1) scholarly books, monographs and chapters; (2) journal publications; (3) conference papers; (4) creative and literary works, consulting reports and case studies; (5) patents, agreement, assignments and companies; and (6) all other research-related outputs.
- 2.4 Research output is measured in terms of the number of publications, reports, designs, performances, exhibitions, etc. In the case of co-authorship and group performance, the counting rule is to pro-rata according to the number of authors/participants involved. For example, a paper with four authors will count as 0.25 for each author. Research output of both academic and research staff is covered. Starting from 2000/01, research output of research postgraduate students is also covered.
- Refereed research output means an academic research output that has been reviewed for merit by a group of professionals ("peers"), a substantial number of whom should be from outside the institution. The form of academic research peer review varies from field to field and from output category to output category. However, the common requirement is that the review be performed by a group of people with the capacity to judge quality at a high level, operating at arm's length with respect to the researcher and his/her department. Acceptance by an editor or conference leader does not by itself constitute "refereeing", although such a process will become "refereed" if the material is sent out for peer review. Items of research book or monograph, article in refereed journal, and refereed paper at a conference are considered to be refereed. Processes internal to the institution - for example, evaluation of manuscripts for inclusion in a department's working paper series do not fall within the definition of "refereeing".
- 2.6 **Prizes and awards** refer to prestigious recognition bestowed by a source external to the institution, whether or not a tangible reward involved. They cover prizes and other awards relating to research received by members of academic/research staff and research postgraduate students during the specified reference period.

3. 高等教育機構的研究成果

- 3.1 隨着全球日趨重視研究和創新的趨勢, 高等教育機構的研發風氣繼續蓬勃發展。二零 零八/零九年度,教資會所資助的高等教育機 構的研究成果項目總數爲 24 634,較一九九 八/九九年度增加 18%。 (表一和圖一)
- 3.2 二零零八/零九年度的研究成果的主要科目範圍包括「人文科學、社會科學及商科」(39%),其次是「生物學及醫學」(27%)、「工程學」(24%)和「自然科學」(10%)。(表一)
- 3.3 同時,「生物學及醫學」的研究成果愈來愈活躍。在一九九八/九九至二零零八/零九年度期間,有關的研究成果數目顯著上升40%。在二零零八/零九年度,「工程學」的研究成果數目亦錄得顯著增幅,較一九九八/九九年度上升了31%。 (表一)

4. 經審閱的研究成果

4.1 香港高等教育機構一向致力提高研發的素質。自二零零三/零四年度起,約70%的研究成果項目屬經審閱的研究成果。在二零零八/零九年度,經審閱的研究成果總數達17719,佔研究成果總數的72%。在二零零八/零九年度「生物學及醫學」及「工程學」的研究成果項目中,分別有84%和75%是經審閱的。(表一和圖一)

3. Research Output of Higher Education Institutions

- 3.1 Along with the increasing global emphasis on research and innovation, R&D undertaken by higher education institutions continues to flourish. In 2008/09, the total number of research output items produced by the higher education institutions funded through the UGC stood at 24 634, representing an increase of 18% over 1998/99. (Table 1 and Chart 1)
- 3.2 The main subject areas of research output in 2008/09 were "humanities, social sciences and business studies" (39%), followed by "biology and medicine" (27%), "engineering" (24%) and "physical sciences" (10%). (Table 1)
- 3.3 Meanwhile, research in "biology and medicine" has been gaining momentum, with a remarkable increase by 40% in terms of research output items during 1998/99 to 2008/09. A significant increase in the number of research output items was also registered for the subject of "engineering" in 2008/09, by 31% when compared with 1998/99. (Table 1)

4. Refereed Research Output

4.1 The higher education institutions in Hong Kong have been making continuous effort in promoting quality of R&D. As from 2003/04, around 70% of the total number of research output items were refereed research output. In 2008/09, the total number of refereed research output items reached 17 719, representing 72% of the total number of research output items. In particular, in "biology and medicine" and "engineering", 84% and 75% respectively of the research output items were refereed in 2008/09. (Table 1 and Chart 1)

5. 獎項

5.1 研發活動所獲獎項的數目,是反映一個經濟體系致力於卓越研究工作的另一個指標。二零零八/零九年度香港研究成果所獲獎項數目為 631 項,較一九九八/九九年度有195%的顯著增長。當中,屬「生物學及醫學」的獎項數目最多,佔 36%,其次是「人文科學、社會科學及商科」(32%)、「工程學」(27%)和「自然科學」(5%)。(表二)

5. Prizes and Awards

5.1 The number of prizes and awards relating to R&D activities is another indicator to reflect the endeavour of an economy to achieve research excellence. This number in Hong Kong saw a notable increase of 195% during 1998/99 to 2008/09, reaching 631 in 2008/09. Among all the prizes and awards in 2008/09, "biology and medicine" took up the largest share of 36%, followed by "humanities, social sciences and business studies" (32%), "engineering" (27%), and "physical sciences" (5%). 
