# Temporary and Disability Assistance Statistics

## **FEBRUARY 2005**

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 611,251 in February 2005, decreasing by 4,001 (-0.7%) from the previous month. Related expenditures totaled \$151,786,689 in February 2005 increasing approximately \$1.1 million (+0.7%) over January 2005.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,772,304 in February 2005, increasing by 5,574 (+0.3%) over January 2005. Food Stamps expenditures totaled \$179,572,879 in February 2005, increasing \$414,843 (+0.2%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For February 2005, SSI recipients (including Mental Hygiene) totaled 633,347 increasing 4,217 (+0.7%) from the previous month. SSI expenditures in February totaled \$315,617,130 increasing approximately \$8.3 million (+2.7%) from January 2005.

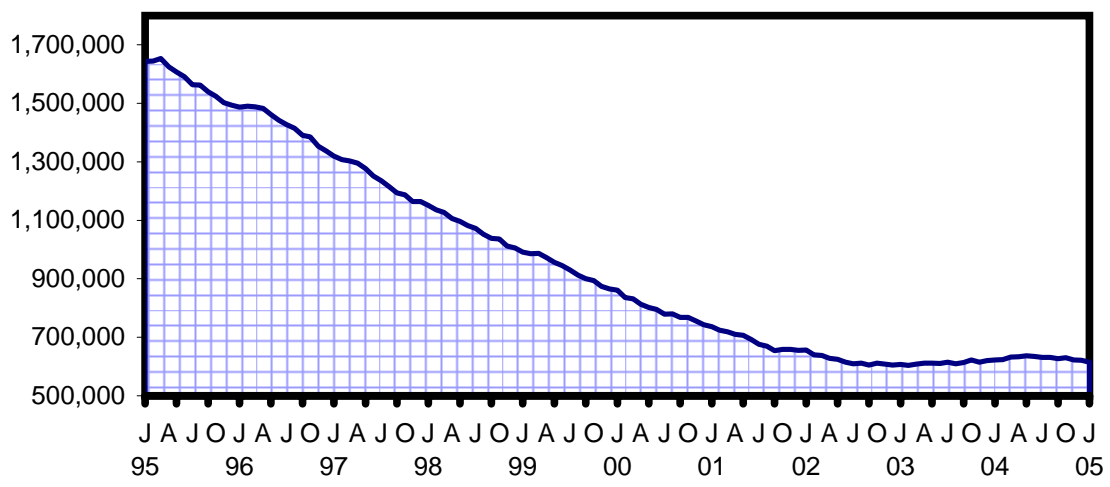

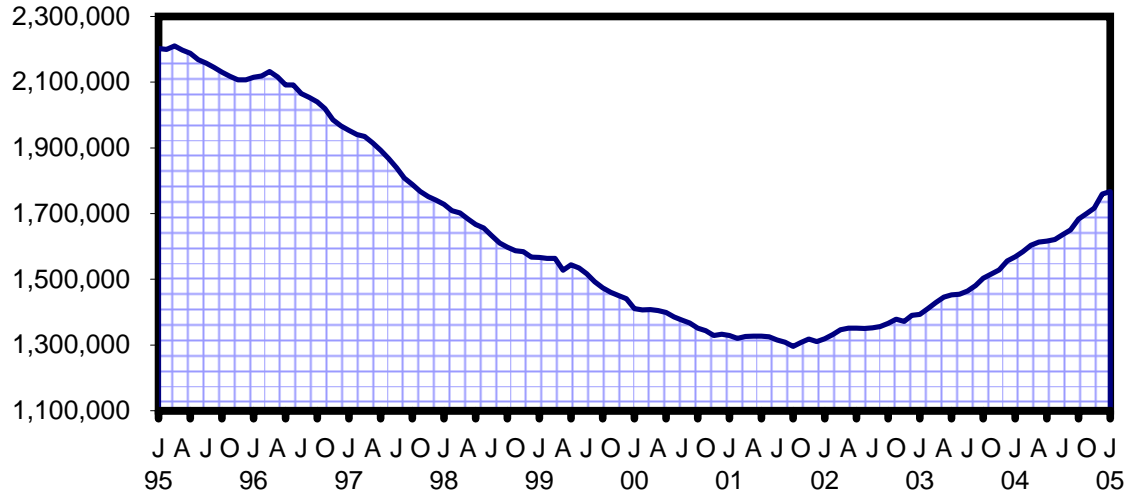

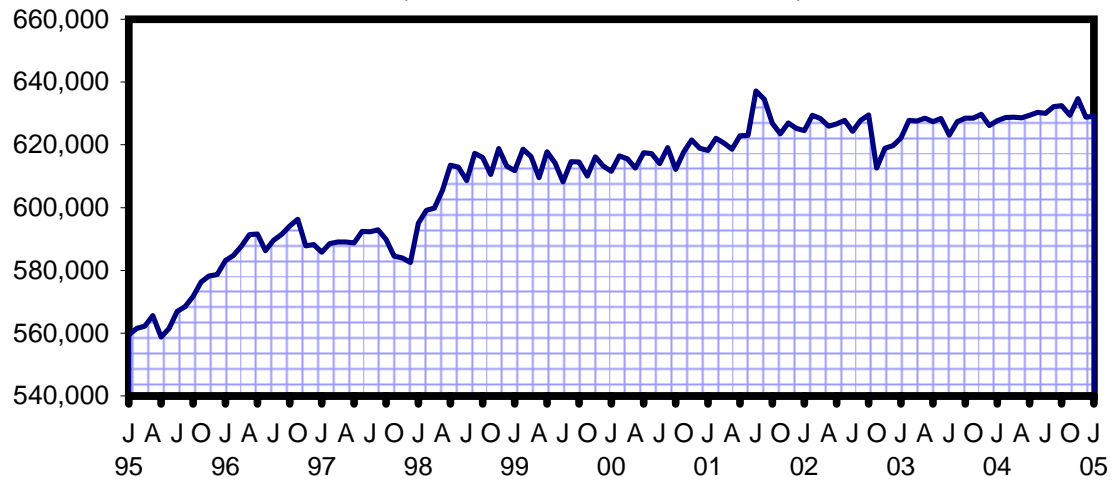
## TEMPORARY ASSISTANCE RECIPIENTS
