#### **HOME PROGRAM**

In addition to managing its open portfolio, the HOME Local Program awarded 51 new contracts through a competitive Request for Proposal (RFP) process during program year 2016. Awards were funded by both new funding as well as deploying prior year HOME funds as noted in the Strategic Plan.

The HTFC does not pre-describe an apportionment of available HOME funds among the goal categories, but rather the allocation of funds among activities is determined by the volume, quality, and feasibility of applications which are submitted. Accomplishments were divided as shown in Tables 1 & 2.

As detailed in the Strategic and Action Plans, past performance is not a guarantee of future activities. Expected unit production was an estimate of the anticipated strategic outcomes based on past activities. HOME Local achieved 81% of its estimated unit outcome provided in the Strategic and Action Plans.

The HOME Local Program continues to provide individualized technical assistance to its subrecipients to ensure compliance with federal HOME regulations and address loss of capacity and staff turnover, all of which effect timely expenditure of funds on eligible units.

#### **CDBG**

With respect to the goal of creating and preserving decent housing, it is estimated in the five-year Consolidated Plan that NYS CDBG funds would be used to improve the availability of affordable housing by rehabilitating approximately 3,400 units. During the first year of the planning period, NYS CDBG funds have been used to rehabilitate 520 affordable housing units.

It was also estimated over the five-year planning period that the NYS CDBG program would provide homeownership assistance to approximately 500 households. The NYS CDBG program has made decent housing more affordable by providing homeownership assistance to 139 households in 2016.

In addition, it was estimated that the NYS CDBG program would fund public facilities and infrastructure projects, benefitting 50,000 annually. During the first year of the planning period, NYS CDBG funds have funded 34 public facilities and infrastructure projects in which 50,000 individuals are projected to benefit from NYS CDBG-funded infrastructure and public facility projects for a one year total of 87,502 benefiting and 576 individuals assisted with HOPWA-funded services.

Finally, with regard to the goal of creating economic opportunities, the State's five-year Consolidated Plan estimated that NYS CDBG-funded economic development activities would create or retain approximately 3,500 jobs and assist 150 businesses over that period. During the first year planning period, NYS CDBG-funded economic development activities have resulted in the creation or retention of 447 full-time equivalent jobs, for the first year.

#### **HOME PROGRAM**

As subrecipients begin to expend new awards and HOME Local continues to fund eligible activities on a regular basis, all of the affordable housing priorities identified by New York State will continue to be furthered. HOME local programs will continue to address affordable rental housing, rehabilitation of existing homes, homebuyer assistance, and creation of new homeownership opportunities.

#### Progress the Jurisdiction has made in carrying out its Strategic Plan and its Action Plan (CDBG).

The majority of recipients awarded during the PY 2000 through PY 2013 annual grant cycles have completed their projects and the associated grant funds have been fully expended. The projects that have not been completed are delayed primarily due to other funding involved in the projects. In most cases, the full amount of CDBG funds has been expended, but accomplishments cannot be documented until the project is online and operational or until jobs or housing units are filled. Recipients of CDBG grants awarded in December 2016 are working on their environmental reviews, client intake, engineering/permitting, and preliminary administrative and program delivery work. Site visits and other technical assistance are used to help projects overcome hurdles that can impede timely completion. Actions have been taken to increase timeliness of project completion and to actively troubleshoot on behalf of recipients who encounter permitting hurdles or need approvals from other state or federal funding agencies before proceeding with their projects.

#### Housing

The 2016 Action Plan had estimated that 680 housing units would be rehabilitated and 100 homes purchased for first-time homebuyers in PY 2016. For the period January 1, 2016 - December 31, 2016, 520 units of housing were fully rehabilitated and 139 families completed home purchases.

#### **Public Facilities**

The 2016 Action Plan had estimated that projects serving 10,000 persons would be completed during the program year. In addition to safe drinking water and wastewater infrastructure projects, this category includes such projects as street improvements, community facility projects, and handicap accessibility improvements. For the period January 1, 2016 - December 31, 2016 recipients completed 5 public facilities activities and reported serving 87,502 persons.

#### **Economic Development**

The Program Year 2016 Action Plan predicted that 700 jobs would be created and/or retained through all economic development activities. In addition, it was estimated that 30 businesses would be assisted through microenterprise activities or by small business. For the period January 1, 2016 to December 31, 2016, under the Economic Development program, 447 full-time equivalent jobs were actually retained or created from economic development activities, including and 146 full-time equivalent jobs through microenterprise and small business activities.

#### **Awards**

The NYS CDBG program provides funding under the three main grant categories of Housing, Public Infrastructure and Facilities, and Economic Development, shown in Table 1. A range of activities are funded under each of these three broad grant categories.

In PY 2016, 45 applicants requested funds for the housing category and proposed activities that include housing rehabilitation, homeownership, replacement of wells and septic systems, and manufactured home replacement. This includes applications received through the competitive housing round which were due to OCR on September 28, 2016. OCR awarded 35 projects totaling \$15,531,603.

Predominant in the Public Infrastructure and Facilities category are activities to supply safe drinking water and to collect and treat wastewater. Twenty-nine (29) public infrastructure and facilities grants were awarded in 2016 for water and sewer activities totaling \$20,726,119. In addition to public infrastructure projects, HTFC also awarded 5 grants totaling \$1,500,000 for the construction of facilities in underserved areas that will provide a range of public services that are funded by other public and private funding sources.

Economic development funds were awarded to projects involving activities that support the expansion of existing industries and businesses with the primary intent of supporting job creation/retention for low- and moderate-income persons. Economic development funds are used to assist traditional economic development projects and small businesses (businesses with 25 or fewer employees) and microenterprise assistance (businesses with 5 or fewer employees). Funds were awarded to small business owners to assist in the expansion of job opportunities for low-and moderate-income persons. Many of New York State's eligible jurisdictions are located in rural areas characterized by dependence on a single primary employer. In order to maintain and enhance job security for the adult population as well as to ensure that local youth will have access to new jobs that promote long-term careers, an essential role of the NYS CDBG program is to support a range of job training, infrastructure creation, financing, industrial modernization, and business development activities. Finally, through the State's Imminent Threat funding category, New York continued to provide housing, public facilities and economic development assistance to communities hard hit by Hurricane Irene and Tropical Storm Lee in 2011.

During Program Year 2016, 39 awards totaling \$12,939,570 were made for all economic development activities. Of the 39 awards, six (6) were for small business, fourteen (14) microenterprise awards, nineteen (19) economic development activities.

#### CDBG

The NYS CDBG program helps New York's smaller municipalities and rural areas achieve their goals to rehabilitate existing affordable housing and to encourage stable neighborhoods through increased home ownership among low- and moderate income households. New York State also continues to use an interagency approach to harness federal, state, and local resources to encourage the viability of existing commercial and residential districts, including encouraging the creation of downtown mixed-use and upper-story housing.

For Program Year 2016, the NYS CDBG program required that applicants requesting housing assistance provide information related to any grievances received related to Fair Housing within that jurisdiction,

as well as the outcome of any adjudicatory actions taken. In addition to the above, NYS CDBG program recipients are responsible for taking specific actions to affirmatively further fair housing practices in their communities, and will be required to report on those specific actions beginning in early 2018. Participants must affirmatively further fair housing in soliciting participating households, determining eligibility, and in conducting all transactions. The Grant Administration Manual explicitly outlines the fair housing provisions and steps which must be taken by communities to achieve "good faith efforts" in their public outreach to ensure fair housing compliance. Recipients are required to document all actions taken, and the results of those actions, in developing a fair housing/affirmative marketing program. Recipients are monitored for compliance with Fair Housing requirements at least once during the life of a grant.

#### **HOME PROGRAM**

The HOME Program successfully met 81% of its estimated goals projected in the Action Plan and will continue as planned to address affordable rental housing, rehabilitation of existing homes, homebuyer assistance, and creation of new homeownership opportunities.

HOME Local continues to provide individualized technical assistance to its subrecipients to ensure compliance with federal HOME regulations and address loss of capacity and staff turnover, all of which effect timely expenditure of funds on eligible units.

#### CDBG

For FY 2016, the OCR reported a total of 520 rehabilitated units and 139 households received homeownership assistance. The State is on target to meet its five year goals for housing.

#### **HOME PROGRAM**

The HOME Program will continue to consider past performance when estimating the outcomes for future action plans despite the fact this is not a guarantee of future activities. HOME will award through a competitive Request for Proposal Process and grant funding based on activities determined by the volume, quality, and feasibility of applications which are submitted, thus remaining flexible to the needs of the communities it serves. As the community needs and requests change so will the outcomes.

## CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c) Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs:

1,563 people were contacted and assessed through eight Solutions To End Homelessness Program (STEHP) Street Outreach programs statewide in 2016. Providers addressed basic physical needs, transportation, emergent health and mental health needs, and encouraged participants to enter local shelters, housing programs and Rapid Re-housing programs. 145 came off the streets into permanent housing while 282 exited to temporary or institutional destinations. 436 were no longer able to be contacted and the remainder were still being served at year end.

#### Addressing the emergency shelter and transitional housing needs of homeless persons:

13,184 people utilized emergency shelter and transitional housing under the STEHP program in 2016. 41 projects assisted homeless individuals and families with the goal of obtaining permanent housing. During their stay, people received case management, essential services, assistance obtaining benefits, education services, employment services, outpatient health services, legal assistance, lifeskills training, mental health and substance abuse counseling, and transportation. 4,903 people exited to permanent housing while 2,534 exited to temporary or institutional destinations. 1,564 left without notice and 1,174 moved to a different shelter or unstable place. The remainder were still being served at year end.

HOPWA also funds one transitional housing facility to meet the needs in one upstate community to assist individuals with HIV/AIDS who are experiencing homelessness. This facility provides temporary housing while the individual works toward establishing more permanent housing and supports.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs:

STEHP currently contracts with 37 Prevention providers whose goal is to provide case management, financial and rental assistance, utility assistance, security deposits, legal services, credit repair and benefit/entitlement advocacy. OTDA stresses housing stability plans and allows contractors to serve participants for the maximum amount of time under current ESG regulations. 22,784 people exited a STEHP Prevention program in 2016. 20,949 people retained permanent housing at exit. The vast majority of the people, (18,996), had their cases resolved within six months.

The HOPWA program also helps low income individuals and families to attain and maintain permenant housing with supports as needed. Tenant based rental assistance, short term rental, mortgage and utility assistance, as well as permanent housing placement services are deployed to assist these households in achieving housing stability.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again:

STEHP currently contracts with 38 Rapid Re-housing providers whose goal is to assist participants in obtaining affordable permanent housing. In order to promote housing stability, OTDA allows Rapid Rehousing contractors to provide services for the maximum amount of time under current ESG regulations and mandates contractors serve a new participant for at least six months with at least case management if the participant is still willing to engage. 2,879 people exited a STEHP Rapid Re-housing program in 2016. 2,571 retained permanent housing at exit. The majority of those that exited, (2,362), used the program for at least three months and up to 24 months.

#### **Fair and Equitable Housing Office**

HCR undertook efforts to focus its internal policies, procedures, and management in a way that efficiently and consistently affirmatively furthers fair housing choice. FEHO implemented several new and improved policies, procedures and best practices, many of which were identified in the New York State Entitlement Jurisdiction Analysis of Impediments to Fair Housing Choice ("AI"). These include:

- Affirmative Fair Housing Marketing Plan ("AFHMP") Guidelines and Standardized Form. FEHO
  revised its AFHMP guidelines and standardized form to assist HCR awardees in developing and
  implementing an effective AFHMP and to ensure that persons identified as least likely to apply
  ("LLA") are aware of available affordable housing opportunities.
- Affirmatively Further Fair Housing ("AFFH") Checklist for Community Development Block Grant Subrecipients. The AFFH Checklist requires HCR awardees of CDBG funds to indicate within 45 days of reward specific AFFH activities it will undertake within one year of award of funds. This is an important tool for cross-collaboration across program areas and to better ensure fair housing compliance.
- Accessibility Design and Construction Certification. The updated certification serves to educate
  owners, general contractors, and architects of their requirements under federal and New York
  State law and notices them of their legal obligation to construct their projects according to the
  specific design and construction requirements.
- HCR also pursued the following actions during the program year to address regulatory barriers to affordable housing year:
- Provided incentives for mixed income family housing developments to promote the integration of neighborhoods; and
- Balanced investments between areas with existing need and neighborhoods with higher opportunity.

#### **Community Development Block Grant Program**

The 2016 Action Plan provided a number of actions that NYS will undertake to eliminate regulatory (and other) barriers to fair affordable housing including the continuance of programs to provide housing rehabilitation. During 2016, the NYS CDBG program made \$15 Million available to provide funds for the ongoing implementation and expansion of housing rehabilitation and home purchase assistance projects. These investments have the effect of reducing the costs involved in maintaining the

affordability of housing units in eligible communities, thereby expanding the availability of housing choice to low/moderate income New Yorkers.

#### Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j):

On an annual basis, due to the age of the housing stock involved, a vast majority of the homes that receive rehabilitation or purchase assistance through the NYS CDBG program are subject to EPA's and HUD's lead-based paint rule. Consequently, recipients are required to test for, and remediate lead-based paint hazards by incorporating such hazards into the rehabilitation scope of work. The level of "lead work" performed in each unit is a function of the amount of federal assistance provided.

Therefore, while not every unit completed in 2016 was made "lead-free", units subject to the lead rule must be completed in a manner consistent with all applicable regulations, which may include paint testing and lead hazard risk assessment, paint stabilization or abatement, and full unit clearance. It should be noted that the NYS CDBG program requires full unit lead risk assessments for every unit receiving rehabilitation assistance, regardless of the level of federal investment.

It should also be noted that many of the awardees of the NYS CDBG program supplement their awards with loans or grants from State and federal housing, environmental health, mental health, and other programs in order to achieve the full scope of the community development project they have planned. Private sector contributions, foundation grants, and self-help contributions of local labor force and equipment also help stretch a CDBG grant.

Encouraging home ownership among long-term renters is a goal of the NYS CDBG program, which results in stabilization of the affordable housing stock and increases the welfare and safety of lower income families and neighborhood stability. In addition to working toward meeting the goals as outlined in the State's 2016-2020 Consolidated Plan, the NYS CDBG program is working toward achieving the overall objectives of New York State regarding housing goals. In the area of housing rehabilitation, standard and decent living conditions are created for a significant number of previously underserved households. Many of these households are occupied by the working poor or retirees on low, fixed incomes, and are not served by existing social services, senior services and other governmental programs. Likewise, public infrastructure projects funded through the NYS CDBG program bring clean drinking water and sewage treatment to many rural and village dwellers who previously had no public infrastructure, and often went years with failing private septic systems and wells that present real health hazards and require thousands of dollars to upgrade. Such projects often have a multiplier effect as the availability of public infrastructure attracts new businesses and spurs private housing development in existing population centers.

#### Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j):

#### **Fair and Equitable Housing Office**

During 2016, NYS Homes and Community Renewal's (HCR) Fair and Equitable Housing Office (FEHO) took several steps to continue to improve and strengthen the Agency's Section 3 outcomes through the

provision of statewide training and technical assistance, and the development of new procedures, forms, templates and notifications outlining the responsibilities and expectations of HCR's awardees. These additional efforts by FEHO were designed to further assist awardees in meeting their Section 3 compliance goals.

The areas FEHO identified to improve within the agency's Section 3 Program were:

- EDUCATE increase education among HCR staff, grantees, Section 3 Residents and Section 3 Business Concerns;
- ASSIST Identify and implement best practices that can be replicated across all awardees, leverage proven techniques and identify strategic partnerships; and
- TRACK and MONITOR review and update policies and procedures through analysis of Section 3 quarterly reporting data. Use statistics to identify areas for improvement and additional training focus.

#### **EDUCATE**

#### **Training**

FEHO's Section 3 Coordinator presented a webinar for the Neighborhood Preservation Coalition (March 2016), participated in a panel discussion at the annual NYS Minority/Women Business Enterprise (M/WBE) Forum (October 2016) and participated in a two-day disabled veterans employment outreach fair, VETCON (October 2016). During the forums participants were encouraged to review the Section 3 Business Concern criteria and if they met the qualifications to register on the HUD Business Registry website. In 2015 when we looked at the HUD registry there were approximately 35 businesses registered. To date there are 215 businesses. The Section 3 Coordinator also conducted 10 technical assistance sessions for awardees, in both urban and rural areas across the State (June-September). The sessions were directed to awardees responsible for Section 3 compliance, including municipalities, public housing authority personnel, developers and contractors/subcontractors. The sessions provided clarity and understanding for some awardees and reinforcement for others on Section 3 compliance and reporting. The sessions also provided information to awardees on creative outreach approaches to identify and engage Section 3 Residents and Business Concerns. Awardees were also encouraged to offer training for residents if there were no current hiring opportunities.

#### **Website**

FEHO has a Section 3 webpage which provides information that assists awardees, as well as potential Section 3 Residents and Business Concerns, in understanding Section 3 compliance. The webpage provides forms and templates for reporting purposes, training and technical assistance webinars, a link to the HUD Business Registry, and a Creative Partnerships listing for potential contracting opportunities.

#### **ASSIST**

Efforts to Increase the Number of Section 3 Business Concerns

FEHO worked with a consulting firm to identify and implement best practice models to increase the number of certified Section 3 Business Concerns across the state. It is intended that these best practices may be shared with HCR awardees in order to assist them in developing successful projects and achieving "greatest extent feasible efforts." In order to determine best practices, information was obtained through several strategies, including:

- Working with New York State agencies to help identify potential Section 3 Business Concerns;
- Partnering with M/WBEs, Service-Disabled Veteran Owned Businesses and Disadvantaged Business Enterprises regarding Section 3 Business Concerns certification process and the qualification requirements; and
- Conducting interviews of other State and Public Housing Authority Section 3 Administrators to identify and review best practices.

#### Partnership Development

FEHO has partnered with HCR program staff and other State agencies, non-profits and faith—based organizations, to further expand knowledge of Section 3 opportunities and to increase Section 3 compliance. FEHO will continue this work into 2017 by providing information through seminars, trainings and its website.

#### **TRACK and MONITOR**

#### **Reporting Compliance**

Starting in January, 2016, FEHO enhanced its reporting requirements. Awardees must now submit a Section 3 Compliance Plan to illustrate their commitment to engaging Section 3 Residents and Business Concerns in contract and employment/training opportunities. The Compliance Plan must include information on the project area, the current workforce, and specific plans for hiring residents and engaging designated businesses. The plan must also include firm commitments that the Section 3 Clause will be included in all sub-contracts and that there will be aggressive outreach and notification of potential employment and contracting opportunities for Section 3 residents and businesses.

#### **Quarterly Reporting**

Starting in January 2016, FEHO implemented a quarterly reporting process, along with the required annual report. Rather than wait until the end of the year to assess the progress being made toward reaching the required minimum goals, FEHO is able to identify shortcomings that may occur during the year, and provide technical assistance as needed.

As FEHO moves forward with enhancing its Section 3 compliance efforts and assisting in the reduction of the number of families living in poverty, the following changes will be incorporated in 2017:

• Quarterly Reporting Data Analysis will be performed after every quarter. This will allow FEHO to have a more comprehensive view of the areas where Section 3 awardees require additional technical

assistance to meet their required minimum goals. These statistics give FEHO the tools needed to identify reporting trends, capital allocations over the life of a project, Section 3 Resident and Business Concern hiring and training needs, and other areas that may require topic specific trainings.

- Matchmaking Events will be held to connect Section 3 Residents and Business Concerns with awardees statewide. This is an innovative way to present Section 3 Residents and Business Concerns with employment and contracting opportunities within their communities.
- On-Site Monitoring of Section 3 qualified projects is an important next step in ensuring compliance. In 2017, FEHO will begin to perform on-site visits in tandem with HCR program staff to establish a Section 3 presence and corroborate quarterly reporting numbers. Information on Section 3 compliance will also be incorporated into the monitoring checklist already utilized program staff.

#### **Community Development Block Grant Program**

The NYS CDBG program, through its housing rehabilitation, home ownership, public infrastructure, public facilities, and economic development funding improves the quality of housing and sanitation and reduces unemployment and underemployment. Housing conditions for renters and homeowners are improved, tenants are empowered to become new home owners, and projects to bring safe drinking water to, and treat wastewater for low- and moderate-income residents are funded. Centers are constructed to provide services to persons in predominantly low- and moderate-income areas. Economic development projects create or retain jobs for low- and moderate-income persons who may have been formerly unemployed or underemployed. Job training to a skill level that will raise employees out of poverty is often a component of CDBG-funded economic development and microenterprise projects.

For Year 2016, the State provided homeownership assistance to 139 households, housing rehabilitation assistance was provided to 520 units of housing. Further, the State provided non-housing assistance in the form of public infrastructure and facilities that benefitted 87,502 persons. In terms of economic development assistance, a total of 63 low-and moderate income microenterprise businesses received assistance, for all economic development activities, 447 full-time equivalent jobs were created or retained.

#### Actions taken to develop institutional structure. 91.220(k); 91.320(j):

In 2016, HCR completed the Governor's strategic state housing plan that provides a roadmap to enhance coordination among various programs administered by the agency. This will result in closer relationships among the divisions and offices in the agency, in order to have the greatest impact on communities and on the provision of affordable housing. This process was necessary to support the goal of the creation or rehabilitation of 100,000 affordable housing units over the next 5 years.

### Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j):

While the NYS CDBG program works very closely and effectively with other state and federal funding agencies in order to leverage the investment of CDBG dollars, the program does not allow public service activities as an eligible project type.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a):

#### **Completion of AI**

The New York State Entitlement Jurisdiction Analysis of Impediments to Fair Housing Choice ("AI") was submitted to HUD in January 2016 to satisfy its Affirmatively Further Fair Housing ("AFFH") obligation. In addition to the communities that fall under the State's entitlement jurisdiction, the AI included an evaluation of the AI documents prepared by 48 HUD entitlement communities and counties located in New York State (exclusive of New York City) in order to identify statewide issues and patterns.

The AI assessed the laws, regulations, administrative policies, procedures, and practices in New York State that affect the ability of individuals to live where they choose free from discrimination on account of their personal attributes which are protected under the FHA and/or New York Human Rights Law. Additional information was also gathered through the public engagement process, which solicited perspectives from fair housing advocates, housing developers, social service providers, the general public, as well as appropriate stakeholders within local and state government agencies.

#### **Summary of Impediments from AI**

Through the AI, HCR continued to fulfill the State's obligation to AFFH by identifying both impediments to fair housing, as well as measureable goals and recommended actions best suited to remove those barriers. The AI identified impediments under the following categories: Available, affordable, and accessible housing; Disparity in access to community assets; Environmental regulatory requirements; Fair Housing education and outreach; Fair housing enforcement; Land use and development regulations; Local sentiment; Private market; Public policy; and Technical assistance for HUD entitlements in New York State. Below is a description of impediments, the corresponding goal, and recommended actions undertaken in 2016.

#### Available, Affordable & Accessible Housing

Through the public engagement process performed as a part of the AI, a lack of available, affordable and accessible housing was one of the most significant and frequently cited impediments to fair housing. In order to remove this impediment, HCR continued to preserve and expand the inventory of affordable and accessible housing throughout New York State. More specifically, and among other things, HCR

incentivized mixed income family housing developments as a means of promoting the integration of neighborhoods, continued and expanded existing housing rehabilitation programs, and sought a balance between revitalizing racially concentrated areas of poverty ("RCAPs") and expanding affordable housing options in higher opportunity areas, as defined in the AI.

#### Disparity in Access to Community Assets

A disparity in access to community assets was also identified as an impediment to fair housing. Accordingly, HCR's goal is to leverage its funding and enhance its policies to provide greater access to community assets and opportunities for members of the protected classes. To that end, HCR, among other things, sought to balance investing in areas of existing need and expanding housing options in neighborhoods with higher opportunity, worked to expand its mobility counseling in Westchester County, and prioritized the development of mixed income family housing in both urban and rural areas by utilizing region-appropriate incentives.

#### Fair Housing Education & Outreach

Through the AI process, HCR identified the lack of knowledge and education regarding fair housing laws and requirements to be an impediment. As detailed below, HCR worked to improve the level of fair housing knowledge among staff, housing developers, real estate professionals, local elected officials, and members of the protected classes.

#### Fair Housing Enforcement

Through its AI, HCR identified a lack of fair housing enforcement as a significant impediment to fair housing. Therefore, in February 2016, HCR contracted with three nonprofit organizations to conduct fair housing testing as part of the New York State's Fair Housing Enforcement Program. Under FEHO's direction, these organizations determined geographic areas of interest and viable targets, recruited testers and conducted paired tests.

FEHO also continued to work towards increasing collaborative efforts with the New York State Division of Human Rights ("DHR"). This included, among other things, working together on the Fair Housing Enforcement Program. FEHO also began to work with DHR and the New York Department of State to educate realtors about fair housing and housing discrimination.

#### **Actions to Overcome Impediments Identified in AI**

In response to findings in the AI that lack of knowledge and education regarding fair housing laws were impediments to fair housing, FEHO launched the New York State Fair Housing Campaign in the spring of 2016. FEHO conducted numerous other sessions and produced additional informational documentation to the populations it serves. These included (i) five regional fair housing roundtables designed to provide a forum for staff members of FEHO to meet with advocates and other members of the

affordable housing and fair housing communities to identify and troubleshoot housing discrimination; (ii) four regional fair housing trainings and a webinar focused on providing education to developers, local officials and other stakeholders on their obligations under federal and state fair housing laws; (iii) a new, more robust and educational FEHO web page; and (iv) an HCR agency-wide quarterly newsletters that served to educate agency staff on FEHO's work, as well as current hot-topics in fair housing.

FEHO also continued to work with HCR's program staff, as well as the Policy and Executive teams, to prioritize the meaningful actions that New York would pursue to address each impediment identified through the Al. While not exhaustive of the meaningful actions that New York pursued in 2016, HCR began to evaluate and, as appropriate, expand the following initiatives throughout the year:

- Produced and ensured that educational initiatives and materials about an individual's rights as a member of a protected class are available, as warranted and practical;
- Continued the Section 8 Mobility Counseling Program and the Section 8 Family Self-Sufficiency Program;
- Launched a new Affirmative Fair Housing Marketing Plan guidelines and standardized form
  to assist in the review of marketing plans for capital projects and to ensure that persons
  identified as least likely to apply ("LLA") are aware of affordable housing opportunities;
- Produced an Affirmatively Furthering Fair Housing ("AFFH") Checklist as a requirement for receiving CDBG funds;
- Published and implemented the "Guide for Applying New York State's Anti-Discrimination
  Policies When Assessing Applicants for State-Funded Housing Who Have Criminal
  Convictions" to give housing providers guidance for assessing individuals with prior criminal
  convictions or pending arrests who are seeking housing in state-funded developments;
- Updated Design and Construction Certification to educate owners, general contractors, and architects of their legal obligation to construct their projects according to the specific design and construction requirements;
- Launched New York State Fair Housing Campaign and conducted regional trainings and advocate meetings;
- Offered incentives for landlords to invest in energy efficiency improvements as a means of decreasing cost burden for lower income renter households; and
- Partnered with DHR and nonprofit fair housing groups to focus on increasing detection of unlawful housing discrimination and enforcement.

#### **Community Development Block Grant Program**

The 2016 Action Plan provided a number of actions that NYS will undertake to eliminate regulatory (and other) barriers to fair affordable housing including the continuance of programs to provide housing rehabilitation. During 2016, the NYS CDBG program made \$15 Million available to provide funds for the ongoing implementation and expansion of housing rehabilitation and home purchase assistance

projects. In addition, for Program Year 2016, the NYS CDBG program required that applicants requesting housing assistance provide information related to any grievances received related to Fair Housing within that jurisdiction, as well as the outcome of any adjudicatory actions taken. In addition to the above, NYS CDBG program recipients are responsible for taking specific actions to affirmatively further fair housing practices in their communities, and will be required to report on those specific actions beginning in early 2018. Participants must affirmatively further fair housing in soliciting participating households, determining eligibility, and in conducting all transactions. The Grant Administration Manual explicitly outlines the fair housing provisions and steps which must be taken by communities to achieve â¿¿good faith effortsâ¿• in their public outreach to ensure fair housing compliance. Recipients are required to document all actions taken, and the results of those actions, in developing a fair housing/affirmative marketing program. Recipients are monitored for compliance with Fair Housing requirements at least once during the life of a grant.

#### **CR-40 - Monitoring 91.220 and 91.230**

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements:

All Solutions to End Homelessness (STEHP/ESG), and HOPWA contracts entered into by OTDA are subject to on-going monitoring throughout the term of the contract. The primary methods include: review of quarterly reports; review of final reports; periodic site visits, including review of randomly-selected case files; and on-going telephone contact with program staff. A site visit by the program manager consists of an overview of the agency and the program, a tour of the site, observation of direct service provision, and meetings with accounting staff. Extensive questions are asked pertaining to the information contained in quarterly reports and based upon the coordinator's knowledge of the program. Contractors call and email with questions about changes in their program, contract requirements, vouchering, and other issues. The program manager also initiates telephone calls to question information contained in programmatic and financial reports.

OTDA employs a compliance officer who assists STHEP and HOPWA program managers in ensuring that contractors meet established M/WBE requirements. Each contractor has a goal of utilizing 15% of its discretionary funds on a certified minority-owned business enterprise and 15% of its discretionary funds on a certified woman-owned business enterprise. Should a contractor identify such discretionary funding, they must submit reports on a quarterly basis demonstrating discretionary funds have been spent with such certified minority or woman owned business.

There are no changes proposed to the State's programs objectives.

The activities and strategies are making an impact on identified needs which are indicated by the amount funded. The funding supports the vision, and the proposed accomplishments will be realized in the next two years. The Office of Community Renewal funds multiple activities which support diversity and helps to serve different needs.

The CDBG program has not identified any barriers to fulfilling the strategies and overall vision and all grant programs are on schedule. Recipients of CDBG grants awarded in December 2016 are working on their environmental reviews, client intake, engineering/permitting, and preliminary administrative and program delivery work. Site visits and other technical assistance are used to help projects overcome hurdles that can impede timely completion. There is no specific activity type that is falling behind schedule.

Actions have been taken to increase timeliness of project completion and to actively troubleshoot on behalf of recipients who encounter permitting hurdles or need approvals from other state or federal funding agencies before proceeding with their projects. Grant disbursements are timely; recipients typically receive CDBG funds within 10 business days of approval.

## Project Outcomes Data measured under the performance standards developed in consultation with the CoC(s):

The performance standards set for the STEHP program intend to encourage contractors to provide long-term stability for their participants. During the RFP process, priority was given to applicants that could demostrate an 85% positive housing outcome rate, meaning the participants exit to equally stable or more stable housing situations. Additionally, each contractor is aware that OTDA is looking for a minimum of a 75% positive housing outcome rate in quarterly reports and during monitoring visits. Should a project not achieve this threshold, OTDA may reallocate some or all of the funds awarded to the contractor.

In September 2016, OTDA held an annual Sharing and Coordination Event meetings in two separate locations in New York State. Invitations were sent to all stakeholders. OTDA solicited input on ESG topics such as HMIS, data sharing, data warehousing, allocation priorities, balance of state and effectiveness of the STEHP program. The afternoon sessions showcased contractors that are demonstrating Best Practices in Rapid Rehousing, Housing First and Coordinated Entry.
