





The Livestock Risk Protection - Feeder Cattle insurance tool enables livestock operations to protect revenue from adverse changes in the price of feeder cattle, creating the opportunity to lock in profits. Run by the USDA's Risk Management Agency, LRP is available through approved insurance agents in SA Stone. Several members of StoneX Financial Inc. – FCM Division, which focuses on livestock risk management, are registered with SA Stone to provide LRP to their clients.

- Available in all 50 states throughout the year
- Producers can insure up to 6,000 head per endorsement/ limit 12,000 per crop year
- Premium is subsidized between 35 and 50% depending on coverage level
- Premium may be paid at the end of the endorsement period
- Insurance periods ranging from 13 weeks to 52 weeks
- Settled to CME national cash price index
