2. **釋義**  
在本規則中，除文意另有所指外——  
**考試** (examination) 指考核本規則指明的科目並按本規則所描述的方式進行的考試。
3. **申請應考**  
任何人如有意參加考試，必須以書面向公證人協會提出申請。  
該申請必須——
  - (a) 採用公證人協會理事會所認可的格式；及
  - (b) 連同附表訂明的申請費用。
4. **舉行及主持考試**
  - (1) 公證人協會可於該會不時決定的時間及地點舉行考試。
  - (2) 公證人協會可自行主持考試，亦可委任主考員代該會主持考試。

## Notaries Public (Examinations) Rules

(Cap. 159, section 73D)

(Enacting provision omitted—E.R. 2 of 2019)

[30 June 2005] L.N. 60 of 2005

(Format changes—E.R. 2 of 2019)

1. (Omitted as spent—E.R. 2 of 2019)
2. **Interpretation**  
In these Rules, unless the context otherwise requires—  
**examination** (考試) means an examination in the subjects specified, and conducted in the manner described, in these Rules.
3. **Application for examination**  
A person who wishes to take an examination must apply to the Society of Notaries in writing. The application must be—
  - (a) in a form approved by the Council of the Society of Notaries; and
  - (b) accompanied by the application fee prescribed in the Schedule.
4. **Holding and conducting of examinations**
  - (1) The Society of Notaries may hold examinations at such times and places as the Society may from time to time determine.

**5. 考試科目及範圍綱要**

- (1) 考試的科目如下 ——
- (a) 匯票；及
  - (b) 公證人實務。
- (2) 考試必須以公證人協會理事會不時決定的範圍綱要為基礎。
- (3) 如有意參加考試的人提出書面要求，公證人協會必須向該人免費提供考試範圍綱要的文本。

**6. 考試費用**

任何人如有意參加考試，必須按公證人協會理事會要求，向該理事會繳付附表訂明的考試費用。

**7. 應考次數不限**

任何人可無限次參加考試，但他必須在單一次的考試中於所有科目考取合格，方符合本條例第 40A(1)(a)(iii) 條的規定。

**8. 通知考試結果**

考試舉行後，公證人協會必須在切實可行範圍內盡快 ——

- (a) 以書面通知每名參加該次考試的人其考試成績；及

- (2) The Society of Notaries may conduct an examination itself or appoint examiners to conduct the examination on the Society's behalf.

**5. Subjects and syllabus of examinations**

- (1) The subjects of the examination are—
- (a) bills of exchange; and
  - (b) notarial practice.
- (2) An examination must be based on a syllabus as the Council of the Society of Notaries may from time to time determine.
- (3) The Society of Notaries must supply, on request in writing by a person who wishes to take an examination and free of charge, a copy of the syllabus.

**6. Examination fee**

A person who wishes to take an examination must pay the examination fee prescribed in the Schedule to the Council of the Society of Notaries on request of the Council.

**7. Person may take examination on unlimited occasions**

There is no limit to the number of occasions on which a person may take an examination, but in order to satisfy the requirement in section 40A(1)(a)(iii) of the Ordinance, a person must pass all subjects in a single examination.

**8. Notification of examination results**

As soon as practicable after an examination has been held, the Society of Notaries must—

- (a) notify in writing each person who has taken the examination of the person's examination result; and
