MARCH 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 612,826 in March 2005, increasing by 1,575 (+0.3%) from the previous month. Related expenditures totaled \$161,752,578 in March 2005 increasing approximately \$10 million (+6.6%) over February 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,782,930 in March 2005, increasing by 10,626 (+0.6%) over February 2005. Food Stamps expenditures totaled \$181,590,629 in March 2005, increasing approximately \$2 million (+1.1%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For March 2005, SSI recipients (including Mental Hygiene) totaled 633,236 decreasing 111 (-0.0%) from the previous month. SSI expenditures in March totaled \$311,787,991 decreasing approximately \$3.8 million (-1.2%) from February 2005.

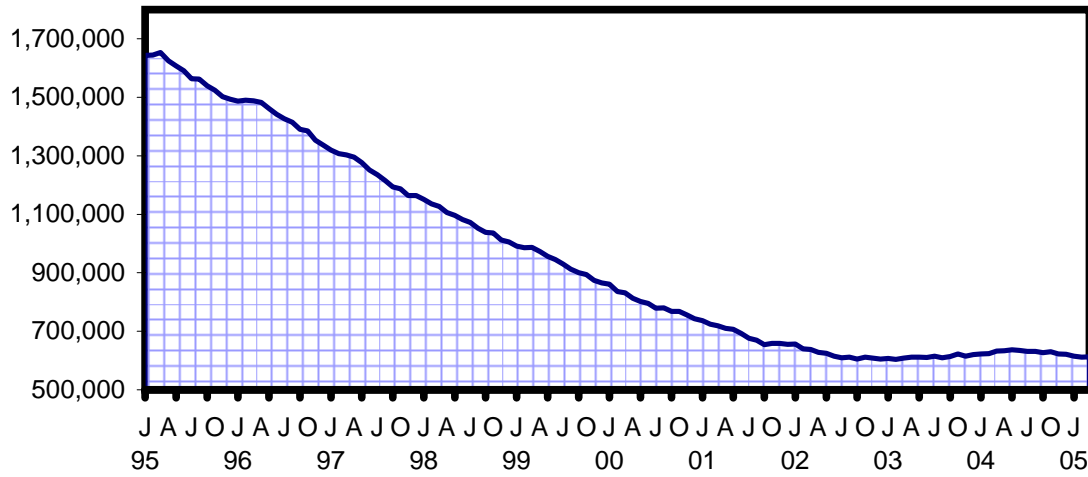

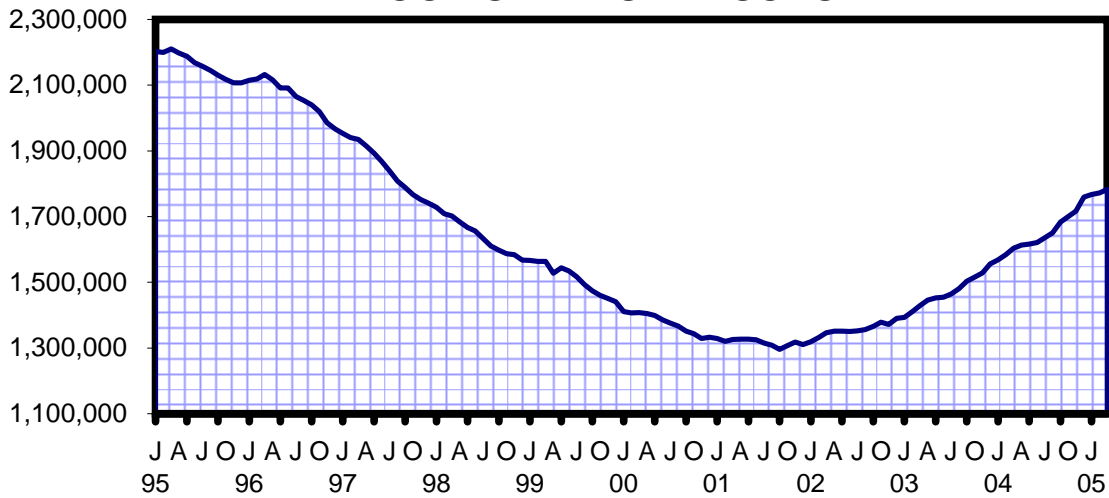

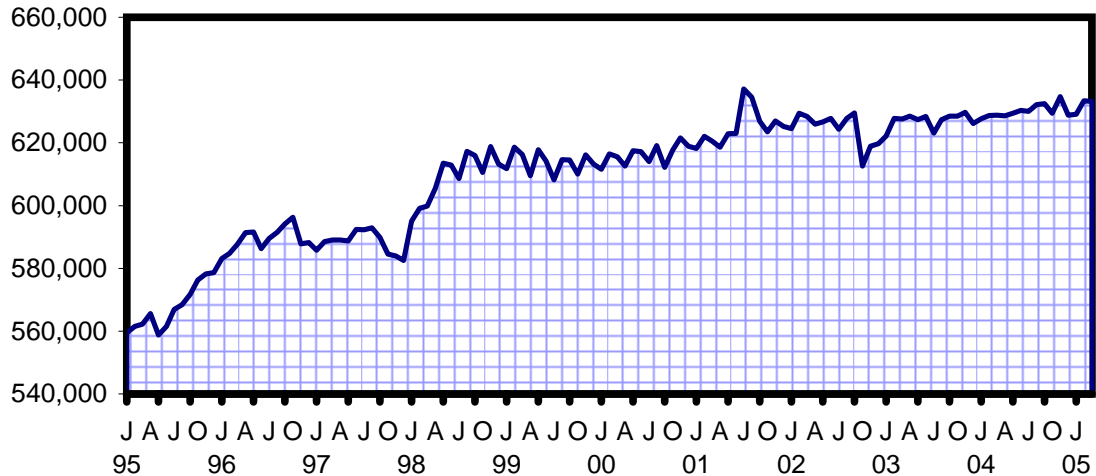
TEMPORARY ASSISTANCE RECIPIENTS
